Intraday EUR/USD: the RSI is capped by a declining trend line, the pair is under pressure and is challenging its support. Suggest short positions below 1.3275 with 1.318 and 1.315 as next targets. The upside breakout of 1.3275 will open the way to 1.3325 and 1.3365.

Weekly chart EUR/USD trend: Bearish

Intraday USD/JPY: the pair is on the upside and is approaching its next resistance. Suggest long positions above 83.9 with 84.5 and 84.9 in sight. The downside penetration of 83.9 will call for a slide towards 83.7 and 83.5.

Weekly chart USD/JPY trend: Bullish

Intraday GBP/USD: the pair remains on the downside and is challenging its support. Suggest short positions below 1.561 with targets at 1.551 and 1.5485. The upside penetration of 1.561 will call for 1.5665 and 1.5715.

Weekly chart GBP/USD trend: Bearish

Intraday USD/CHF: the pair has struck against its resistance and should pull back ahead of a further up move. Suggest long positions above 0.96 with targets at 0.9695 and 0.9725 in extension. Below 0.96 look for further downside with 0.957 and 0.9525 as targets.

Weekly chart EUR/GBP trend: Bearish

Intraday EUR/JPY: the pair remains on the downside and is challenging its support. Suggest short positions below 111.8 with targets at 111.25 and 110.85 in extension. Above 111.8 look for further upside with 112.2 and 112.5 as targets.

Weekly chart EUR/JPY trend: Bearish

Intraday EUR/CHF: the pair remains under pressure and is approaching its previous low. Suggest short positions below 1.2835 with targets at 1.275 and 1.2685 in extension. Above 1.2835 look for further upside with 1.2875 and 1.2925 as targets.

Weekly chart EUR/CHF trend: Bearish

Intraday AUD/USD: the RSI is badly directed. Suggest short positions below 0.9915 with targets at 0.981 and 0.9775 in extension. Above 0.9915 look for further upside with 0.995 and 0.9985 as targets.

Weekly chart AUD/USD trend: Range
