01. FXMarketSpace is now fully operational and open for trading

On the 26th of March FXMarketSpace announced that it was fully operational and open for trading, launching the world's first centrally-cleared, global foreign exchange (FX) platform for the over-the-counter market.

The platform allows you to access the full power of the global currency market with...

- > the broadest, most diverse trading community
- > the most transparent and anonymous trading access
- > the most technologically advanced trading platform

The launch, which represents a major evolution in the FX industry, arrives on schedule, coming just 11 months after the announcement of FXMarketSpace in May 2006.

Mark Robson, Chief Executive Officer, FXMarketSpace said:
"Today is a landmark event for FXMarketSpace and we believe for the FX industry as a whole. The launch of our platform means that the doors are now open for a broader and more diverse range of institutions to participate in the global FX market, which will benefit from better execution and the increased efficiencies that we can offer. Our existing customers are already convinced of our ability to meet their needs and deliver high-performance results. FXMarketSpace will fuel further rapid growth in our industry and create new opportunities for our customers."

"The FX market has talked about a centrally-cleared platform for years," said Rick Sears, President and Chief Sales Officer, FXMarketSpace, "and today we are able to make it available to everyone for the first time. We have utilised the core competencies available to us at CME, Reuters and within our own team to create a platform that can transform the industry and take it to a new level."

02. FSA Authorisation for FXMarketSpace



On the 8th of February, FXMarketSpace was authorised by the Financial Services Authority as an Alternative Trading System. The FSA is responsible for regulating financial services in the UK and aims to promote efficient, orderly, and fair financial markets. This authorisation was an important and significant step leading up to the official launch of the FXMarketSpace platform.


