



September 2020 compared with August 2020

Industrial producer prices up by 0.3% in both euro area and EU

In September 2020, industrial producer prices rose by 0.3% in both the **euro area** and the **EU**, compared with August 2020, according to estimates from **Eurostat, the statistical office of the European Union**. In August 2020, prices increased by 0.1% in the **euro area** and by 0.2% in the **EU**.

In September 2020, compared with September 2019, industrial producer prices decreased by 2.4% in the **euro area** and by 2.2% in the **EU**.



Monthly comparison by main industrial grouping and by Member State

Industrial producer prices in the **euro area** in September 2020, compared with August 2020, increased by 0.8% in the energy sector and by 0.1% for intermediate goods, while prices remained stable for capital goods, durable consumer goods and non-durable consumer goods. Prices in total industry excluding energy remained stable.

In the **EU**, industrial producer prices increased by 0.7% in the energy sector and by 0.1% for intermediate goods, while prices remained stable for capital goods, durable consumer goods and non-durable consumer goods. Prices in total industry excluding energy remained stable.

The highest increases in industrial producer prices were recorded in **Ireland** (+4.3%), **Hungary** (+1.2%) and the **Netherlands** (+0.9%), while the largest decreases were observed in **Cyprus** (-1.3%), **Estonia** and **Finland** (both -0.8%), **Greece** and **Lithuania** (both -0.3%).

Annual comparison by main industrial grouping and by Member State

Industrial producer prices in the **euro area** in September 2020, compared with September 2019, decreased by 8.4% in the energy sector and by 1.6% for intermediate goods, while prices rose by 0.2% for non-durable consumer goods, by 0.8% for capital goods and by 1.3% for durable consumer goods. Prices in total industry excluding energy decreased by 0.3%.

In the **EU**, industrial producer prices decreased by 8.1% in the energy sector and by 1.5% for intermediate goods, while prices rose by 0.4% for non-durable consumer goods, by 0.9% for capital goods and by 1.4% for durable consumer goods. Prices in total industry excluding energy decreased by 0.2%.

The largest decreases in industrial producer prices were observed in **Cyprus** (-7.7%), **Lithuania** (-7.3%) and **Greece** (-5.6%), while the only increases were recorded in **Malta** (+1.7%), **Hungary** (+0.9%), **Slovenia** and **Slovakia** (both +0.3%).

Geographical information

The **euro area** (EA19) includes Belgium, Germany, Estonia, Ireland, Greece, Spain, France, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Malta, the Netherlands, Austria, Portugal, Slovenia, Slovakia and Finland.

The **European Union** (EU27) includes Belgium, Bulgaria, Czechia, Denmark, Germany, Estonia, Ireland, Greece, Spain, France, Croatia, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Hungary, Malta, the Netherlands, Austria, Poland, Portugal, Romania, Slovenia, Slovakia, Finland and Sweden.

Methods and definitions

The **index of producer prices** shows (in the national currency of the country concerned) changes in the ex-works sale prices of all products sold on the domestic market, excluding imports. Euro area and EU indices refer to overall weighted price changes. The figures are not calendar day or seasonally adjusted.

Total industry covers NACE rev.2 sections B to D + E36.

Revisions and timetable

Compared with data issued in the News Release 143/2020 of 1 October 2020, the monthly percentage change remains unchanged for August 2020 at +0.1% in the euro area and at +0.2% in the EU. The annual percentage change has been revised from -2.5% to -2.6% in the euro area and from -2.3% to -2.4% in the EU.
