
October 2023 compared with September 2023

Industrial producer prices up by 0.2% in both the euro area and the EU

Down by 9.4% in the euro area and by 8.7% in the EU compared with October 2022

In October 2023, industrial producer prices rose by 0.2% in both the **euro area** and the **EU**, compared with September 2023, according to estimates from **Eurostat, the statistical office of the European Union**. In September 2023, prices increased by 0.5% in both the **euro area** and the **EU**.

In October 2023, compared with October 2022, industrial producer prices decreased by 9.4% in the **euro area** and by 8.7% in the **EU**.



Monthly comparison by main industrial grouping and by Member State

Industrial producer prices in the **euro area** in October 2023, compared with September 2023, increased by 1.0% in the energy sector and by 0.1% for durable consumer goods, while prices remained stable for capital goods, and prices decreased by 0.1% for non-durable consumer goods and by 0.3% for intermediate goods. Prices in total industry excluding energy decreased by 0.2%.

In the **EU**, industrial producer prices increased by 0.6% in the energy sector, while prices remained stable for both capital goods and durable consumer goods, and prices decreased by 0.1% for non-durable consumer goods and by 0.3% for intermediate goods. Prices in total industry excluding energy decreased by 0.2%.

The biggest monthly increases in industrial producer prices were observed in **Ireland** (+4.9%), **Italy** (+2.2%) and the **Netherlands** (+0.7%), while the largest decreases were recorded in **Luxembourg** (-3.7%), **Latvia** (-2.7%) and **Greece** (-1.9%).

Annual comparison by main industrial grouping and by Member State

Industrial producer prices in the **euro area** in October 2023, compared with October 2022, decreased by 25.0% in the energy sector and by 5.3% for intermediate goods, while prices increased by 3.7% for both capital goods and durable consumer goods and by 4.2% for non-durable consumer goods. Prices in total industry excluding energy decreased by 0.2%.

In the **EU**, industrial producer prices decreased by 22.7% in the energy sector and by 5.3% for intermediate goods, while prices increased by 3.1% for durable consumer goods, by 3.5% for capital goods and by 4.0% for non-durable consumer goods. Prices in total industry excluding energy decreased by 0.3%.

The largest annual decreases in industrial producer prices were recorded in **Bulgaria** (-25.9%), **Belgium** (-20.5%) and **Greece** (-14.7%). The highest annual increases were recorded in **Luxembourg** (+18.4%), **Slovenia** (+2.5%) and **Slovakia** (+1.1%).

Geographical information

The **euro area** (EA20) includes Belgium, Germany, Estonia, Ireland, Greece, Spain, France, Croatia, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Malta, the Netherlands, Austria, Portugal, Slovenia, Slovakia and Finland.

The **European Union** (EU27) includes Belgium, Bulgaria, Czechia, Denmark, Germany, Estonia, Ireland, Greece, Spain, France, Croatia, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Hungary, Malta, the Netherlands, Austria, Poland, Portugal, Romania, Slovenia, Slovakia, Finland and Sweden.

Methods and definitions

The **index of producer prices** shows (in the national currency of the country concerned) changes in the ex-works sale prices of all products sold on the domestic market, excluding imports. Euro area and EU indices refer to overall weighted price changes. The figures are not calendar day or seasonally adjusted.

Total industry covers NACE rev.2 sections B to D + E36.

Revisions and timetable

Compared with data issued in the News Release 125/2023 of 7 November 2023, the monthly percentage increase for September 2023 remained unchanged at +0.5% in the euro area and has been revised from +0.6% to +0.5% in the EU. The annual percentage decrease remained unchanged at -12.4% in the euro area and at -11.2% in the EU.
